DRAFT 0348	13208/2023	An ordinance authorizing the Mayor and the Director of Public Service and Safety pursuant to Section 721.15© of the Ohio Revised Code to discard municipal personal property (including motor vehicles and/or road machinery) that is no longer needed for any municipal purpose or public use, or is obsolete, or is unfit for any municipal purpose or public use and has no value, and declaring an emergency.
DRAFT 0349	13209/2023	An ordinance for the purpose of authorizing the Mayor and Director of Public Service and Safety to enter into a contract with the auditor of the State of Ohio for the purpose of performing a financial audit for the year 2022 of the City of Warren; and declaring an emergency.
DRAFT 0350	13210/2023	An ordinance for the purpose of authorizing the City Director of Law, on behalf of the City of Warren, Ohio, to execute the opioid Litigation Settlement Agreements between the Ohio Settling Local Governments and TEVA, Allergan, CVS, Walgreens, and Walmart, and declaring an emergency.
DRAFT 0351	13211/2023	An ordinance for the purpose of the City's Mayor, and the Director of Safety and Service, on behalf of the City of Warren, to enter into a written agreement authorizing the purchase of real property located at 999 Mahoning Avenue NW, formerly known as the "Powerhouse," for the purpose of securing the parcel for the Summit Dam Removal, and declaring an emergency.
DRAFT 0352R2	13212/2023	An ordinance for the purpose of transferring within the general fund and appropriating from the unappropriated, unencumbered balances within various city funds and declaring an emergency.
DRAFT 0353	13213/2023	An ordinance for the purpose of authorizing the payment of specific orders or contracts upon receipt of certification of the Fiscal Officer of the sufficiency7 of funds for said expenditures, and declaring an emergency.

DRAFT 0345	STEINBECK	A resolution authorizing the Mayor and the Director o Public Service and Safety to apply for, accept, and enter into Water Pollution Control Loan Fund Agreement(s) on behalf of the City of Warren, Ohio, for plant and pump station improvements Phase 2 – materials procurement and construction, and designating a dedicated repayment source for the loan: Water Pollution Control Fund 703.
DRAFT 0346	STEINBECK	An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety, for and on behalf of the City of Warren, Ohio, to advertise for bids and enter into a contract(s) for plant and pump station improvements Phase 2 – materials procurement and construction, on behalf of the Water Pollution Control Department, and declaring an emergency.
DRAFT 0347	STEINBECK	An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety to advertise for bids and enter into a one-year contract(s) or two-year contract(s), each with an additional one-year renewable clause, for the repair of utility road cuts for the Water Department, and declaring an emergency.
