DRAFT 0331	4700/2023	A resolution for the purpose of confirming the Mayoral re-appointment of Marva Smith as a member of the Warren City Board of Health for the term beginning January 1, 2023, and ending December 31, 2027, and declaring an emergency.

DRAFT 0332	13194/2023	An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety to enter into a cooperative agreement with the Western Reserve Port Authority for the purpose of economic development and project assistance and declaring an emergency.

DRAFT 0336	13198/2023	An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety, for and on behalf of the City of Warren, Ohio, to advertise for bids and enter into contract(s) for heating, ventilation, and air conditioning (HVAC) renovations at the Warren Government Center building at 258 East Market Street, and declaring an emergency.
DRAFT 0337	13199/2023	An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety to advertise for bids and enter into contract(s) for the costs of constructing, reconstructing, renovating, equipping, furnishing, and otherwise improving city structures, and declaring an emergency.
DRAFT 0338	13200/2023	An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety to advertise for bids and enter into contract(s) for the costs of resurfacing and otherwise improving one or more Municipal parking lot(s) and declaring an emergency.

DRAFT 0340R	13202/2023	An ordinance for the purpose of appropriating from the unappropriated, unencumbered balances of the General Fund; appropriating from the unappropriated, unencumbered balances of various city funds, and appropriating from the unappropriated, anticipated revenue of certain city funds and declaring an emergency.
DRAFT 0341	13203/2023	An ordinance for the purpose of authorizing the payment of specific orders or contracts upon receipt of certification of the Fiscal Officer of the sufficiency of funds for said expenditures, and declaring an emergency.
DRAFT 0330	13204/2023	An ordinance for the purpose of: directing the Trumbull County Board of Elections to place before the electors of the City of Warren, at a Special Election (Primary Elections) to be held on Tuesday, May 2, 2023, in

accordance with Section 3501.01(D) of the Ohio Revised Code, the question “Shall a Commission be chosen to frame a Charter for the City of Warren?”; directing the Trumbull County Board of Elections, by and through said ballot, to provide for the election to said commission of no more than Fifteen Electors of the City of Warren; and declaring an emergency.
