DRAFT 0490	13333/2024	AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE PAYMENT OF SPECIFIC ORDERS OR CONTRACTS UPON RECEIPT OF CERTIFICATION OF THE FISCAL OFFICER OF THE SUFFICIENCY OF FUNDS FOR SAID EXPENDITURES, AND DECLARING AN EMERGENCY.
