ORDINANCE FOR THE **PURPOSE** AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY ON BEHALF OF THE CITY OF WARREN, TO ENTER INTO WRITTEN AGREEMENT(S) WITH THE BOARD OF COUNTY COMMISSIONERS OF TRUMBULL COUNTY, OHIO, ON BEHALF OF TRUMBULL COUNTY, OHIO FOR THE PURPOSE OF DESIGNATING THE CITY OF WARREN AND TRUMBULL COUNTY, OHIO, AS UNITS OF GOVERNMENT, TO PARTICIPATE AS A CONSORTIUM \mathbb{N} THE HOME INVESTMENT PARTNERSHIPS PROGRAM, AS AUTHORIZED BY THE NATIONAL AFFORDABLE HOUSING ACT, AND DECLARING AN EMERGENCY.

WHEREAS, The National Affordable Housing Act permits units of local government to participate as consortia in the HOME Investment Partnership Program, as authorized by the National Affordable Housing Act; and

WHEREAS, this Council determined that it would be in the best interests of the City of Warren, and its residents, to participate with Trumbull County, Ohio, as a consortium for purposes of the aforementioned program; and

WHEREAS, the City of Warren through its Community Development Department is acting as the lead agency for the Warren – Trumbull Home Consortium; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Mayor and the Director of Public Service and Safety be, and hereby are, authorized, for and on behalf of the City of Warren, to enter into written agreement(s) with the Board of Commissioners of Trumbull County, Ohio, for and on behalf of Trumbull County, Ohio, for the purpose of designating the City of Warren (as lead agency) and Trumbull County, Ohio, as units of government, to participate as a consortium in the HOME Investment Partnerships Program, as authorized by the National Affordable Housing Act.

Section 2: That the terms and provisions of any such agreement(s), and the form thereof, being entered into, shall be acceptable to the Law Director of the City of Warren and the Director of the City Community Development Department, as well as the Mayor and the Director of Public Service and Safety. Any such agreement shall be in accordance with applicable rules, regulations and guidelines of said program.

Section 3: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason that the availability of affordable housing within the City of Warren and Trumbull County may be more fully insured at the earliest possible time and without undue delay. WHEREFORE, this Ordinance shall go into immediate effect.
