AN **ORDINANCE** FOR THE **PURPOSE** AUTHORIZING THE MAYOR OF THE CITY OF WARREN TO APPLY, AND TO ENTER INTO AN INTERLOCAL AGREEMENT(S), FOR THE PURPOSE OF ACQUIRING GRANT MONIES FROM THE "2015 BYRNE **EDWARD** MEMORIAL ASSISTANCE GRANT (JAG) PROGRAM" FOR THE CITY'S POLICE DEPARTMENT, AND FOR THE FURTHER PURPOSE OF OBLIGATING THE CITY OF TO IMPLEMENT THE ACTIVITIES WARREN ENCOMPASSED WITHIN SAID GRANT AND TO MAKE PROPER EXPENDITURES AND RECEIVE FUNDS INCIDENTAL TO SAID GRANT, AND DECLARING AN EMERGENCY.

WHEREAS, there are presently available to the City of Warren grant monies relative to the "2015 Edward Byrne Memorial Justice Assistance Grant (JAG) Program"; and

WHEREAS, the City desires to participate in the aforementioned project and the grant monies therefor; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Mayor be, and hereby is, authorized, for and on behalf of the City of Warren, to apply for a 2015 Edward Bryne Memorial Justice Assistance Grant (JAG), and the Mayor further be, and hereby is, authorized, for and on behalf of the City of Warren, to enter into whatever interlocal agreement(s) that may be necessary or useful for the acquisition and use of the funds applied for.

Section 2: That any such agreement(s) as provided for in Section 1 of this Ordinance shall be in substantial compliance and conformity with the "AGREEMENT" which is attached hereto as Exhibit "A", the terms and conditions of said attached "AGREEMENT" being hereby approved and authorized by this Council. Said Exhibit "A" is hereby incorporated herein, for all purposes, as if fully rewritten herein.

Section 3: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason that the integrity of the equipment and technology of the Police Department may be more fully ensured at the earliest possible time and without undue delay. WHEREFORE, this Ordinance shall go into immediate effect.

Interlocal Agreement Between Trumbull County and the City of Warren

2015 Edward Byrne Memorial Justice Assistance Grant (JAG) Program

This agreement is made and entered into this ____ day of _____, 2015 by and between Trumbull County and the City of Warren, acting by and through their governing bodies.

Now therefore, the parties agree as follows:

Section 1

That the parties shall jointly apply for the aforementioned grant.

Section 2

That the City of Warren will be the lead agency for said grant. The City of Warren will administer said grant.

Section 3

That a 10% administration fee will be paid to the City of Warren from the grant monies.

Section 4

That the City of Warren will transfer 25% of their grant funds to Trumbull County as it is a disparate jurisdiction. In light of the foregoing, the proceeds from the aforementioned grant will be distributed in accordance with the attached "Exhibit A".

Section 5

That each party to this agreement will be responsible for its own actions in providing services or purchasing equipment and shall not be liable for any civil liability that may arise from the furnishing of the service or equipment by any other party.

Section 6

That by entering into this agreement, the parties do not intend to create any obligations, express or implied, other then those set out herein; further, this agreement shall not create any rights in any party not signatory hereto.
