AN ORDINANCE FOR THE PURPOSE OF TRANSFERRING BETWEEN DEPARTMENTS OF THE GENERAL FUND; APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED BALANCES OF CERTAIN CITY FUNDS; TRANSFERRING WITHIN THE COMMUNITY DEVELOPMENT BLOCK GRANT FUND AND DECLARING AN EMERGENCY.

WHEREAS, there exists a need to: appropriate from the unappropriated, anticipated revenue of the General Fund; transfer within the General Fund; transfer within certain city funds; appropriate from the unappropriated, anticipated revenue of various city funds; and appropriate from the unappropriated, unencumbered balances of certain city funds; and
