3635                      4608/16      A resolution for the purpose of confirming the Mayoral reappointment of Dr. John Robertson as a member of the Fair Housing Commission of the City of Warren for the term beginning on January 1, 2017 and ending on December 31, 2019, and declaring an emergency.

3636                      12687/16      An ordinance for the purpose of authorizing a contract(s) for the Project known as 2017 City Road Program, and further authorizing the execution of the project grant agreement, and other proper documents, with the State of Ohio Public Works Commission to secure approval and grant funding or assistance for the project under Section 2K Article VIII of the Constitution of Ohio and Sections 164.01 to 164.13 of the Ohio Revised Code, and declaring an emergency.

3638                      12689/16      An ordinance for the purpose of authorizing a contract(s) for the Project known as the Tod and Atlantic Resurfacing Project, and further authorizing the execution of the project grant agreement, and other proper documents, with the State of Ohio Public Works Commission to secure approval and grant funding or assistance for the project under Section 2K Article VIII of the Constitution of Ohio and Sections 164.01 to 164.13 of the Ohio Revised Code, and declaring an emergency.

3639                      12690/16      A ordinance for the purpose of, enacting and subsection (9) to subsection (a) of Section 171.03 (“Imposition of Tax.”) of Chapter 171 (“Income Tax”) of the Codified Ordinances of the City of Warren, Ohio, having been approved by the requisite number of voters, to provide (Effective January 1, 2017) for an additional one-half of one percent (1/2%) per annum rate of income taxation on income earned on and after January 1, 2017, through December 31, 2021, for the purpose of providing additional funds for the General Fund of the City of Warren for the staffing and operation of the Police and Fire Departments and Road Maintenance Program of the City of Warren, Ohio, and declaring an emergency.

3621                      12691/16      An ordinance authorizing the Mayor and the Director of Public Service and Safety to impose a moratorium on the granting of building permits or certificates of occupancy for any building, structure, use or change of use that would enable the cultivation, processing, or retail sale of medical marijuana for a period not to exceed one year from the effective date of this ordinance, in order to allow Council and the City of Warren Planning Commission to review applicable Ohio statues, criminal codes and the City of Warren zoning code relative to such use, and declaring an emergency.
