AN ORDINANCE FOR THE PURPOSE OF APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED 2016 BALANCES OF CERTAIN CITY FUNDS; AND DECLARING AN EMERGENCY.
