TITLE

AN ORDINANCE FOR THE PURPOSE OF REPEALING ORDINANCE NO. 12741/17 IN ITS ENTIRETY AND AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE AND SAFETY TO ADVERTISE FOR BIDS AND ENTER INTO A ONE YEAR CONTRACT(S) OR TWO YEAR CONTRACT(S) EACH WITH AN ADDITIONAL ONE YEAR RENEWABLE CLAUSE FOR THE REMOVAL AND/OR DISPOSAL OF SOLID SLUDGE FROM THE CENTRIFUGE UNIT OF THE CITY OF WARREN'S WATER FILTRATION PLANT, AND DECLARING AN EMERGENCY.

WHEREAS, there will exist a need for solid sludge removal and disposal at the City's Water Filtration Plant; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Director of Public Service and Safety be, and hereby is, authorized to advertise for bids and enter into a one year contract(s) or two year contract(s) each with an additional one year renewable clause for solid sludge removal and/or disposal from the centrifuge unit at the City of Warren's Water Filtration Plant in accordance with plans and specifications on file with the Director of Public Service and Safety, and, after advertising for bids according to law, to enter into whatever contract(s) which may be necessary or useful to accomplish said purpose.

Section 2: That funds for payment of said contract(s) shall be paid from Account No. 701-400-530-000.

Section 3: That the contract(s) shall first be approved by the Law Director, and the City Auditor be, and hereby is, authorized to disburse said funds upon receipt of proper vouchers, signed by the proper persons, for the stated purpose and for no other purpose.

Section 4: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason that the integrity of the City's Water Department may be more fully insured at the earliest possible time and without undue delay. WHEREFORE, this Ordinance shall go into immediate effect.
