AN ORDINANCE FOR THE PURPOSE OF TRANSFERRING WITHIN THE GENERAL FUND; TRANSFERRING WITHIN VARIOUS CITY FUNDS; APPROPRIATING FROM THE UNAPPROPRIATED, ANTICIPATED REVENUE OF VARIOUS CITY FUNDS; AND APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED BALANCES OF CERTAIN CITY FUNDS AND DECLARING AN EMERGENCY.

WHEREAS, there exists a need to: transfer within the General Fund, transfer within various City funds, appropriate from the unappropriated, anticipated revenue of various City funds and appropriate from the unappropriated, unencumbered balances of certain City funds; and

WHEREAS, this Ordinance constitutes an emergency measure, in part, in that the same provides for the usual daily operation of the municipal departments; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:
