ORDINANCE FOR THE **PURPOSE** APPROPRIATING FROM THE UNAPPROPRIATED, ANTICIPATED 2020 REVENUE OF CERTAIN CITY THE FUNDS; APPROPRIATING **FROM** UNAPPROPRIATED, UNENCUMBERED 2019 BALANCES OF THE GENERAL FUND; AND FROM THE UNAPPROPRIATED, APPROPRIATING **UNENCUMBERED 2019 BALANCES OF VARIOUS CITY** FUNDS, AND DECLARING AN EMERGENCY.

ORDINANCE NO. 12916 2020

WHEREAS, there exists a need to: appropriate from the unappropriated, anticipated 2020 revenue of certain City funds; appropriate from the unappropriated, unencumbered 2019 balances of the General Fund; and appropriate from the unappropriated, unencumbered 2019 balances of various City funds to provide for the usual daily operations of the City of Warren.

WHEREAS, this Ordinance constitutes an emergency measure, in part, in that the same provides for the usual daily operation of the municipal departments; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That there be, and hereby is, appropriated from the unappropriated, anticipated 2020 revenue of certain City funds, the sums as follows:

Section 2: That there be, and hereby is, appropriated from the unappropriated, unencumbered 2019 balances of the General Fund, the sums as follows:

Section 3: That there be, and hereby is, appropriated from the unappropriated, unencumbered 2019 balances of various City funds, the sums as follows:

Motor Vehicle Levy Fund 203-305-560-000	Capital Expenditures	\$ 3,150.00
Street Maintenance Fund 205-305-530-000	Contracted Services	\$ 24,000.00
Environmental Services 706-550-530-000	Contracted Services	\$ 4,210.00
Water Department 701-400-530-000	Contracted Services	\$ 18,000.00
Probation-Municipal Court 221-210-530-000	Contracted Services	\$ 6,200.00
Drug Law Enforcement Fund 213-017-560-000	Capital Expenditures	\$ 1,980.00

Section 4: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason that the appropriations are necessary for the continued daily operation of the affected departments. WHEREFORE, this Ordinance shall go into immediate effect.
