AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY TO ADVERTISE FOR BIDS AND ENTER INTO A ONE (1) YEAR, OR, IN THE ALTERNATIVE, FOR A PERIOD OF UP TO FIVE (5) YEAR(S), CONTRACT(S) FOR THE STREET SWEEPING OF VARIOUS STREETS IN THE CITY OF WARREN, OHIO AND DECLARING AN EMERGENCY.

WHEREAS, it has been previously determined by a study of some Departments of the City of Warren, Ohio that cost savings to the City would be accomplished by contracting for street sweeping; and

WHEREAS, the present contract for street sweeping is due to expire, and a new contract should be entered into to provide for an uninterrupted street sweeping program; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Mayor and the Director of Public Service and Safety be, and hereby is, authorized to advertise for bids and enter into a one (1) year, or, in the alternative for a period of up to five (5) years, contract(s) according to law for the street sweeping of various streets in the City of Warren, Ohio as determined by the priority list of the file in the office of the Director of Public Service and Safety and/or the office of the Engineering, Planning and Building Department of the City of Warren, Ohio.

Section 2: That said contract(s) shall be for a term of one (1) year, or, in the alternative, for a period of up to five (5) years, with any such multi-year contract(s) to include an annual rate increase, if any, to be based upon the Regional Consumer Price Index.

Section 3: That the funds for said contract(s) will be paid from Account No. 203-305-530-000 Contracted Services.

Section 4: That the contract(s) shall first be approved by the Law Director, and the City Auditor be, and hereby is, authorized to disburse said funds upon receipt of proper vouchers, signed by the proper persons, for the stated purpose and for no other purpose.

Section 5: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason to enter into a new contract in a timely fashion to provide for an uninterrupted street sweeping program. WHEREFORE, this Ordinance shall go into immediate effect.
