## TITLE

AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY, FOR AND ON BEHALF OF THE CITY OF WARREN, OHIO, TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT(S) FOR THE PROVIDING OF MATERIALS FOR AND THE CONSTRUCTION OF THE DRY WEATHER OVERFLOW RELIEF SEWER PROJECT ON BEHALF OF THE WATER POLLUTION CONTROL DEPARTMENT, AND DECLARING AN EMERGENCY.

ORDINANCE NO. 12932/2020

WHEREAS, the City of Warren, Ohio owns, operates and maintains a sanitary sewage collection system in conformity with all Government and EPA Regulations; and

WHEREAS, in the year 2014, the City of Warren was forced to open a sanitary sewer overflow (SSO) in the downtown area to relieve basement flooding in buildings along West Market Street on Courthouse Square; and

WHEREAS, the City of Warren desires to close this (SSO) and has performed a comprehensive study of its collection system to determine the best alternatives to accomplish said purpose and the estimated costs of construction in order to complete and submit a project nomination for the WPCLF (Water Pollution Control Loan Fund) to secure a low interest loan from the above mentioned WPCLF (Water Pollution Control Loan Fund); and

WHEREAS, the City of Warren, Ohio has retained AECOM Technical Services, Incorporated to review the existing conditions and designed a new sanitary sewer to divert the flow from the Grohl Alley area; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Mayor and Director of Public Service and Safety be, and hereby are, authorized, for and on behalf of the City of Warren, Ohio to advertise for bids and enter into a contract(s) for the providing of materials for and the construction of the Dry Weather Overflow Relief Sewer Project for and on behalf of the Water Pollution Control Department.

Section 2: That any contract(s) to be entered into or participated in for the providing of materials for and the construction of the Dry Weather Relief Sewer Project for and on behalf of the Water Pollution Control Department shall first be approved by the Law Director, and the City Auditor be, and hereby is, authorized to disburse said funds upon receipt of the proper vouchers, signed by the proper persons, for the stated purpose and for no other purpose.

Section 3: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason to maintain the integrity of the City of Warren, Ohio Waste Water Facility and Pump Stations. WHEREFORE, this Ordinance shall go into immediate effect and be in force from and after the earliest period allowed by law.
