TITLE

AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY, FOR AND ON BEHALF OF THE CITY OF WARREN, OHIO, TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT(S) FOR THE PROVIDING OF MATERIALS FOR AND THE CONSTRUCTION OF THE HIGH STREET SANITARY SEWER PROJECT ON BEHALF OF THE WATER POLLUTION CONTROL DEPARTMENT, AND DECLARING AN EMERGENCY.

ORDINANCE NO. 12934/2020

WHEREAS, the City of Warren, Ohio owns, operates and maintains a sanitary sewage collection system in conformation with all Government and EPA Regulations; and

WHEREAS, in the Year 2006, the City of Warren, Ohio completed the construction of the Downtown Sewer Separation Projects that converted our combined collection system in the downtown area into separate storm and sanitary systems; and

WHEREAS, the City of Warren discovered deficiencies in the sanitary laterals in the area of High Street, N.E. and Elm Road, N.E.; and

WHEREAS, the sanitary sewer which services this area is too shallow to accept the flow from these sanitary laterals in conformation with all Government and EPA Regulations; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Mayor and Director of Public Service and Safety be, and hereby are, authorized, for and on behalf of the City of Warren, Ohio to advertise for bids and enter into a contract(s) according to law for the providing of materials for and the construction of the High Street Sanitary Sewer Project on behalf of the Water Pollution Control Department.

Section 2: That any contract(s) to be entered into or participated in for the providing of materials for and the construction of the High Street Sanitary Sewer Project on behalf of the Water Pollution Control Department shall first be approved by the Law Director, and the City Auditor be, and hereby is, authorized to disburse said funds upon receipt of the proper vouchers, signed by the proper persons, for the stated purpose and for no other purpose.

Section 3: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason to maintain the integrity of the City of Warren, Ohio Waste Water Facility. WHEREFORE, this Ordinance shall go into immediate effect and be in force from and after the earliest period allowed by law.
