Section 1: That the Council of the City of Warren, Ohio approves filing an application for financial assistance under the Ohio Department of Natural Resources (ODNR) NatureWorks Grant Program for tree restoration of the Perkins Property Tree Enhancement Project located in the City of Warren, Ohio.

Section 2: That the Director of Public Service and Safety be, and hereby is, authorized and directed to execute and file an application with the Ohio Department of Natural Resources (ODNR) NatureWorks Grant Program and to provide all information and documentation required to become eligible for possible funding assistance for said project.

Section 3: That the Auditor of the City of Warren agrees to obligate the funds required to satisfactorily complete the proposed project and to become eligible for reimbursement under the terms and conditions of the Ohio Department of Natural Resources (ODNR) NatureWorks Grant Program.

That this Resolution is hereby declared to be an emergency measure Section 4: necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason that the City of Warren may timely comply with funding and and programming deadlines established by the Ohio Department of Natural Resources (ODNR) NatureWorks Grant Program.
