ORDINANCE FOR THE PURPOSE APPROPRIATING FROM THE UNAPPROPRIATED, **UNENCUMBERED 2019 BALANCES OF CERTAIN CITY** FUNDS; APPROPRIATING FROM UNAPPROPRIATED, UNENCUMBERED BALANCES OF THE GENERAL APPROPRIATING FROM THE UNAPPROPRIATED; ANTICIPATED 2020 REVENUE OF VARIOUS CITY FUNDS; APPROPRIATING FROM UNAPPROPRIATED, ANTICIPATED 2020 REVENUE OF THE GENERAL FUND AND TRANSFERRING WITHIN THE GENERAL FUND AND DECLARING AN EMERGENCY.

WHEREAS, there exists a need to: appropriate from the unappropriated, unencumbered 2019 balances of certain City Funds; appropriate from the unappropriated, unencumbered 2019 balances of the General Fund; appropriate from the unappropriated, anticipated 2020 revenue of various City funds, appropriate from the unappropriated, anticipated 2020 revenue of the General Fund and transfer within the General Fund to provide for the usual daily operations of the City of Warren.
