## TITLE

AN ORDINANCE TO REVISE THE CODIFIED ORDINANCES BY ADOPTING THE CURRENT REPLACEMENT PAGES AND DECLARING AN EMERGENCY.

ORDINANCE NO. 12956/2020

WHEREAS, certain provisions within the Codified Ordinances should be amended to conform with current State law as required by the Ohio Constitution; and

WHEREAS, various ordinances of a general and permanent nature have been passed by Council which should be included in the Codified Ordinances; and

WHEREAS, Council has heretofore entered into a contract with the Walter H. Drane Company to prepare and publish such revision; and

WHEREAS, the codification of such ordinances, together with the new matter to be adopted, the matters to be amended and those to be repealed are before the Council; NOW THEREFORE:

BE IT ORDAINED BY THE COUNCIL of the City of Warren, State of Ohio:

Section 1. That the ordinances of the City of Warren, Ohio, of a general and permanent nature, as revised, recodified, rearranged and consolidated into component codes, titles, chapters and sections within the 2020 Replacement Pages to the Codified Ordinances are hereby approved and adopted.

Section 2. That the following sections and chapters are hereby added, amended or repealed as respectively indicated in order to comply with current State law:

Any summary publication of this Ordinance shall include a complete listing of these sections. Notice of adoption of each new section by reference to its title shall constitute sufficient publication of new matter contained therein.

Reserved. (Previously "Criminal Child Enticement")

Section 4. That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, welfare and safety and for the further reason that there exists an imperative necessity for the earliest publication and distribution of the current Replacement Pages to the officials and residents of the City of Warren, so as to facilitate administration, daily operation and avoid practical and legal entanglements. WHEREFORE, this ordinance shall take effect and be in force from and after the earliest period allowed by Law.
