AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND DIRECTOR OF PUBLIC SERVICE AND SAFETY TO ADVERTISE FOR BIDS AND ENTER INTO A ONE-YEAR CONTRACT BEGINNING ON JANUARY 1, 2021 AND ENDING DECEMBER 31, 2021 WITH AN ADDITIONAL ONE YEAR RENEWABLE CLAUSE FOR THE MANAGEMENT, OPERATIONS AND PARKING ENFORCEMENT SERVICES OF THE FRANKLIN STREET PARKING DECK AND VARIOUS PARKING FACILITIES WITHIN THE CENTRAL BUSINESS DISTRICT OF THE CITY OF WARREN.

ORDINANCE NO. 12968/2020

WHEREAS, the City of Warren will continue to be in need of management, operations and parking enforcement services for the day-to-day operations of the Franklin Street Parking Deck and various parking facilities within the Central Business District of the City of Warren; and

WHEREAS, the City of Warren is committed to a program of revitalization and redevelopment in the downtown area; and

WHEREAS, the management of a comprehensive vehicle parking plan is required to assist in and to compliment the revitalization and redevelopment; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Mayor and the Director of Public Service and Safety be, and they hereby are, authorized to advertise for bids for management services for the day-to-day operations of the City's Franklin Street parking deck, management and operation of the City's long-term and short-term parking operations and parking enforcement operations within the central business district of the City of Warren, in accordance with plans and specifications therefor in the office of the Director of Public Service and Safety, and after advertising for said bids according to law, to enter into whatever contract(s) are necessary or useful to accomplish said purpose. Said one-year contract(s) to begin on January 1, 2021 and end on December 31, 2021 with an additional one year renewable clause which can only be enacted by mutual agreement.

Section 2: That the costs of said management contract will be paid from the Contract Services Account, Downtown Parking Fund 715-253-530-000.

Section 3: That the contract shall first be approved by the Law Director, and the City Auditor be, and hereby is, authorized to disburse said funds upon receipt of proper vouchers, signed by the proper persons, for the stated purpose and for no other purpose.

Section 4: That this Ordinance is hereby necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason that the present management contract will expire on December 31, 2020. WHEREFORE, this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
