AN ORDINANCE FOR THE PURPOSE OF APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED 2019 BALANCES OF CERTAIN CITY FUNDS AND APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED 2019 BALANCES OF THE GENERAL FUND AND DECLARING AN EMERGENCY.

ORDINANCE NO. 12982/2020

WHEREAS, there exists a need to: appropriate from the unappropriated, unencumbered 2019 balances of certain City funds and appropriate from the unappropriated, unencumbered 2019 balances of the General Fund to provide for the usual daily operations of the City of Warren.

WHEREAS, this Ordinance constitutes an emergency measure, in part, in that the same provides for the usual daily operation of the municipal departments; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That there be, and hereby is, appropriated from the unappropriated, unencumbered 2019 balances of certain City funds, the sums as follows:
