AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND DIRECTOR OF PUBLIC SERVICE AND SAFETY TO ENTER INTO A TEN-YEAR LEASE AGREEMENT BEGINNING ON APRIL 13, 2021 AND CONCLUDING ON APRIL 12, 2031 WITH THE SOCIAL SECURITY ADMINISTRATION OF THE U.S. GENERAL SERVICES ADMINISTRATION (GSA) FOR AGENCY SPACE LOCATED AT THE CITY OF WARREN, OHIO GOVERNMENT SERVICES BUILDING COMMONLY KNOWN AS 258 EAST MARKET STREET, WARREN, OHIO AND DECLARING AN EMERGENCY.

WHEREAS, the City of Warren is the owner of real property commonly referred to as the Warren Government Services Building located at 258 East Market Street, Warren, Ohio 44483; and

WHEREAS, it is deemed advisable to lease a portion of said real property; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Mayor and the Director of Public Service and Safety be, and hereby are, authorized to enter into a ten-year lease agreement beginning on April 13, 2021 and concluding on April 12, 2031 with the Social Security Administration of the U.S. General Services Administration (GSA) for agency space located at the City of Warren, Ohio Government Services Building commonly known as 258 East Market Street, Warren, Ohio.

Section 2: That the funds obtained from the lease(s) shall be earmarked and secured in the City Redevelopment fund upon receipt.

Section 3: That the lease agreement shall first be approved by the Law Director, and the City Auditor be, and hereby is, authorized to disburse said funds upon receipt of proper vouchers, signed by the proper persons, for the stated purpose and for no other purpose.

Section 4: That this Ordinance is hereby necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason that it is necessary to proceed with the lease of the aforedescribed real property at the rearliest possible time and without indue delay. WHEREFORE, this require nance shall go into immediate effect.
