AN **ORDINANCE** FOR THE **PURPOSE** TRANSFERRING WITHIN THE GENERAL FUND; TRANSFERRING WITHIN VARIOUS CITY FUNDS; AND APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED 2019 BALANCES OF THE GENERAL FUND AND DECLARING AN EMERGENCY,

WHEREAS, there exists a need to: transfer within the General Fund; transfer within various City Funds and appropriate from the unappropriated, unencumbered 2019 balances of the General Fund to provide for the usual daily operations of the City of Warren.
