### **TITLE**

AN ORDINANCE AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY PURSUANT TO SECTION 721.15(C) OF THE OHIO REVISED CODE TO DISCARD MUNICIPAL PERSONAL PROPERTY (INCLUDING MOTOR VEHICLES AND/OR ROAD MACHINERY) THAT IS NO LONGER NEEDED FOR PUBLIC USE, OR IS OBSOLETE, UNFIT FOR MUNICIPAL USE AND HAS NO VALUE, AND DECLARING AN EMERGENCY.

WHEREAS, Section 721.15(C) - Disposition of property unneeded, obsolete or unfit for municipal purposes of the Ohio Revised Code authorizes the legislative authority of a Municipal Corporation, under particular circumstances, to discard municipal personal property of the City (including motor vehicles and/or road machinery) that is not needed for public use, or is obsolete, unfit for municipal use and has no value; and

WHEREAS, the City of Warren, Ohio is the owner of municipal personal property (including motor vehicles and/or road machinery) that is no longer needed for public use, or is obsolete, unfit for municipal use and has no value; and

WHEREAS, said municipal personal properties (including motor vehicles and/or road machinery), as fully rewritten herein, have no value, are no longer needed, nor serve municipal purposes; and

WHEREAS, this Council and the Administration of the City of Warren, Ohio desires to exercise the authority granted pursuant to said Section 721.15(C) - Disposition of property needed, obsolete or unfit for municipal purposes of the Ohio Revised Code; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That this Council and the Administration of the City of Warren, Ohio, hereby determines that the municipal personal property (including motor vehicles and/or road machinery as fully rewritten herein, is no longer needed for public use, is obsolete, unfit for municipal use and has no value.
