AN ORDINANCE FOR THE PURPOSE OF REPEALING AND REPLACING ORDINANCE NUMBER 12887/19 AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY TO ADVERTISE FOR BIDS AND ENTER INTO CONTRACT(S) FOR THE COSTS OF REPAIR OF THE WARREN COURTHOUSE SQUARE BIRD FOUNTAIN LOCATED IN COURTHOUSE SQUARE IN THE CITY OF WARREN, OHIO.

ORDINANCE NO. 13083/2021

WHEREAS, the Warren Courthouse Square Bird Fountain located at Courthouse Square in the City of Warren is in a state of disrepair which creates a dangerous situation to both employees, equipment and the citizens of the City of Warren and replacement should be done; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Mayor and Director of Public Service and Safety be, and hereby are, authorized to advertise for bids and enter into contract or contracts for the repair of the Warren Courthouse Square Bird Fountain located in Courthouse Square in the City of Warren, Ohio in accordance with plans and specifications therefore on file in the office of the Director of Public Service and Safety. After advertising for bids according to law, the Mayor and the Director of Public Service and Safety are hereby authorized to enter into whatever contracts(s) which may be useful or necessary to accomplish said purpose.

Section 2: The Warren Rotary Club is donating \$50,000.00 (Fifty Thousand Dollars) to this project and the remainder of funds necessary for payment of said contract(s) shall be paid from the Coronavirus Fiscal Recovery Fund: 226-250-560-000.

Section 3: That the contract(s) shall be approved by the Law Director, and the City Auditor be, and hereby is, authorized to disburse said funds upon receipt of proper vouchers, signed by the proper persons, for the stated purpose and for no other purpose.

Section 4: That this Ordinance is necessary for the immediate preservation of the public peace, health, welfare and safety, and for the further reason that the Warren Courthouse Square Bird Fountain located in Courthouse Square in the City of Warren, Ohio to be replaced as it presents a dangerous condition to employees, equipment and the citizens of the City of Warren, Ohio and shall be more fully insured at the earliest possible time and without undue delay. WHEREFORE, this ordinance shall take effect and be in force from and after the earliest period allowed by law.
