AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY, FOR AND ON BEHALF OF THE CITY OF WARREN, TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT FOR THE DESIGN AND INSTALLATION OF A PLAYGROUND AND PRESCHOOL BANKSHOT COURT AT PACKARD PARK.

ORDINANCE NO. 13/16/2022

WHEREAS, the City of Warren is responsible for the maintenance of the Packard Park Playground; and

WHEREAS, the Packard Park Playground provides outdoor recreation space for children; and

WHEREAS, the Packard Park Playground is in need of replacement as the existing playground does not meet current playground safety standards; and

WHEREAS, the Packard Park Playground is eligible for the EPA SEP funding disbursed through Eastgate Regional Council of Governments; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

- Section 1: That Warren City Council hereby approves the advertisement for bid for the design and construction of this project.
- Section 2: That the Mayor and the Director of Public Service and Safety be, and hereby are, authorized, for and on behalf of the City of Warren, to enter into a contract for the design, excavation and installation of a new playground and preschool bankshot court at Packard Park.
- Section 3: That the project will consist of one contract for the design of a new playground space, removing and disposing of existing playground equipment, excavation, to prepare the site, and the installation of new playground equipment and a preschool Bankshot court.
- Section 4: The City of Warren will seek reimbursement from the EPA SEP settlement funds managed and disbursed by The Eastgate Regional Council of Governments.
- Section 5: That the City of Warren acknowledges and understands this project has been approved by the Ohio EPA and any changes must first be submitted for approval prior to construction.
- Section 6: That it is hereby found and determined that all formal actions of the Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were open to the public and in compliance with the law.
- Section 7: That the contract(s) shall first be approved by the Law Director, and the City Auditor be, and hereby is, authorized to disburse said funds upon receipt of proper vouchers, signed by the proper persons, for the stated purpose and for no other purpose.

Section 8: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare, and safety, and for the further reason that said funding and the proposed project relative thereto may be secured at the earliest possible time and without undue delay. WHEREFORE, this Ordinance shall go into immediate effect.
