AN ORDINANCE FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SERVICE AND SAFETY TO ADVERTISE FOR BIDS AND ENTER INTO CONTRACT(S) FOR THE 2022 LOCAL ROAD PROJECT, AND DECLARING AN EMERGENCY.

ORDINANCE NO. 13/19/2022

WHEREAS, the City of Warren has prepared plans and specifications for the project known as the 2022 Local Road Project; and

WHEREAS, the City of Warren deems the project necessary in the public interest and it should be initiated at the earliest possible time; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Mayor and Director of Public Service and Safety be, and hereby are, authorized to advertise for bids for the 2022 Local Road Project in accordance with the study and plans on file in the office of the Director of Public Service and Safety. After advertising for bids according to law, the Mayor and Director of Public Service and Safety are hereby authorized to enter into whatever contract(s) which may be useful or necessary to accomplish the said project.

Section 2: That said contract(s) shall be paid for from funds properly allocated by the City Auditor.

Section 3: That the contract(s) first shall be approved by the Law Director, and the City Auditor be, and hereby is, authorized to disburse said funds upon receipt of proper vouchers, signed by the proper persons, for the stated purpose and for no other purpose.

Section 4: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare, and safety, and for the further reason that is necessary to initiate the project at the earliest possible time during good construction weather. WHEREFORE, this Ordinance shall go into immediate effect
