ORDINANCE FOR THE **PURPOSE** APPROPRIATING FROM THE UNAPPROPRIATED, ANTICIPATED 2022 REVENUE OF CERTAIN CITY APPROPRIATING FROM THE UNAPPROPRIATED, ANTICIPATED 2022 REVENUE OF THE GENERAL FUND, TRANSFERRING WITHIN VARIOUS CITY FUNDS, TRANSFERRING WITHIN THE GENERAL FUND, AND APPROPRIATING FROM THE UNAPPROPRIATED, UNENCUMBERED BALANCES OF CERTAIN CITY FUNDS, AND DECLARING AN EMERGENCY.
