AN ORDINANCE FOR THE PURPOSE OF AMENDING THE TRAFFIC CONTROL MAP AND FILE ESTABLISHED BY SECTIONS 307.01 AND 307.02 OF THE TRAFFIC CODE OF THE CODIFIED ORDINANCES OF THE CITY OF WARREN BY ESTABLISHING AND DESIGNATING "NO PARKING" ON THE EAST AND WEST SIDES OF SOUTHWEST BOULEVARD S.W., FROM PALMYRA ROAD S.W. TO DEERFIELD AVENUE S.W., THE NORTH AND SOUTH SIDES OF LANE DRIVE S.W., FROM MAIN AVENUE S.W. TO MARTIN STREET S.W., THE NORTH AND SOUTH SIDES OF MARTIN STREET S.W., FROM LANE DRIVE S.W. TO VALLEY AVENUE S.W., AND THE EAST AND WEST SIDES OF VALLEY AVENUE S.W. FROM MARTIN STREET S.W. TO 3RD STREET S.W., DURING THE HOURS OF 6:00 A.M. TO 6:00 P.M. MONDAY THROUGH FRIDAY, AND DECLARING AN EMERGENCY.

ORDINANCE NO. 13167/2022

WHEREAS, it is now determined that the current parking of motor vehicles on the east and west sides of Southwest Boulevard S.W., from Palmyra Road S.W. to Deerfield Avenue S.W., the north and south sides of Lane Drive S.W. from Main Avenue S.W. to Martin Street S.W., the north and south sides of Martin Street S.W. from Lane Drive S.W. to Valley Avenue S.W., and the east and west sides of Valley Avenue S.W. from Martin Street S.W. to 3rd Street S.W. causes a hindrance to the free flow of traffic during the hours of 6:00 A.M. to 6:00 P.M., Monday through Friday; NOW THEREFORE

BE IT ORDAINED by the Council of the City of Warren, State of Ohio:

Section 1: That the Traffic Control Map and File established by Sections 307.01 and 307.02 of the Traffic Code of the Codified Ordinances of the City of Warren be, and hereby are, amended as follows:

By the designation of "No Parking" on the east and west sides of Southwest Boulevard S.W. from Palmyra Road S.W. to Deerfield Avenue S.W., the north and south sides of Lane Drive S.W. from Main Avenue S.W. to Martin Street S.W., the north and south sides of Martin Street S.W. from Lane Drive S.W. to Valley Avenue S.W., and the east and west sides of Valley Avenue S.W. from Martin Street S.W. to 3rd Street S.W., during the hours of 6:00 A.M. to 6:00 P.M., Monday through Friday.

Section 2: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, welfare, and safety, and for the further reason that the parking of motor vehicles on said Southwest Boulevard S.W. from Palmyra Road S.W. to Deerfield Avenue S.W., the north and south west sides of Lane Drive S.W. from Main Avenue S.W. to Martin Street S.W., the north and south sides of Martin Street S.W. from Lane Drive S.W. to Valley Avenue S.W., and the east and west sides of Valley Avenue S.W. from Martin Street S.W. to 3rd Street S.W. during the hours in question should be controlled to a greater degree without undue delay due to the present obstruction of traffic caused thereby. WHEREFORE, this Ordinance shall go into immediate effect.
