THE FOLLOWING IS A SUMMARY LEGISLATION FROM THE JULY 27, 2022  
REGULAR MEETING OF COUNCIL:

**DRAFT NO.**      **RES. NO.**

**0275**                      **4696/2022**                      A resolution for the purpose of honoring Margaret M. Scott for over thirty-five years of service on the Warren City Board of Health.

**DRAFT 0264**      **13143/2022**                      An ordinance for the purpose of repealing ordinance number 11461/01 that established Chapter 753, which prohibited body piercing, and the various sections thereof, within the City of Warren, and declaring an emergency.

**DRAFT 0276**      **13144/2022**                      An ordinance for the purpose of repealing Chapter 1757 “Regulating Tattoo Establishments” of the Codified Ordinances and replacing with Chapter 1757 “Establishing Regulations for Body Art Tattooing and Piercing: within the City of Warren, and declaring an emergency.

**DRAFT 0277**      **13145/2022**                      An ordinance for the purpose of authorizing the Mayor and the Director of Public Service and Safety, on behalf of the City of Warren, Ohio to enter into an agreement with the Trumbull County Land Reutilization Corporation (TCLRC) for the purpose of managing grant funds from the Ohio Department of Development Brownfield Remediation Program within the City of Warren, and as authorized under Ohio Revised Code Section 5722.02; and declaring an emergency.

**DRAFT 0279**      **13146/2022**                      An ordinance for the purpose of authorizing the payment of specific orders or contracts upon receipt of certification of the Fiscal Officer of the sufficiency of funds for said expenditures, and declaring an emergency.

**DRAFT 0280R2**      **13147/2022**                      An ordinance for the purpose of transferring within certain city funds and appropriating from the unappropriated, unencumbered 2021 balances of various city funds, and declaring an emergency.

**DRAFT 0272A**      **13148/2022**                      An ordinance for the purpose of appropriating from the unappropriated, unencumbered 2021 balances of various city funds, transferring within the General Fund, appropriating from the unappropriated, anticipated 2022 revenue of the General Fund, and declaring an emergency.

**FIRST READING**

**DRAFT 0278R2 WHITE**                      An ordinance consenting to the execution of an agreement between the Board of Commissioners of Trumbull County Ohio and Cleveland Steel Container Corporation providing for tax incentives by a program of abatement of real property taxes over a period of ten years for the adoption of a project to establish a new facility within the enterprise zone located within the City of Warren and declaring an emergency.
